## **RULES AND REGULATIONS**

- 1. ANY PERSON(S) USING THIS CENTER MUST FOLLOW THE RULES AND REGULATIONS SIGNED BY THE PRESIDENT OF THE POLISH FRIENDSHIP "ZGODA" SOCIETY.
- 2. THE BUILDING MANAGER AND STAFF MEMBERS, HAVE THE RIGHT TO REFUSE ANY PERSON OR GROUP ENRTY ONTO THE PREMISES.
- 3. POSSESSION OF ANY WEAPONS, EXPLOSIVES, GAS, AND OTHER DANGEROUS MATERIALS ARE PROHIBITED AND MAY BE PROSECUTED.
- 4. LIQUOR MAY BE SERVED ONLY BY THE CERTIFIED BARTENDERS. BRINGING IN YOUR OWN DRINKS AND/OR OUTSIDE LIQUOR IS PROHIBITED AND VIOLATORS WILL BE PROSECUTED.
- 5. ALL USERS MUST COMPLY WITH THE CITY OF VANCOUVER REGULATIONS AND THE VANCOUVER FIRE DEPARTMENT REGULATIONS.
- 6. DAMAGE TO ANY PROPERTIES IN THIS SOCIETY WILL BE PROSECUTED. THE RESPONSIBLE PERSON WILL BE LIABLE TO COVER THE COST OF THE DAMAGE.
- 7. ANY USER OF THESE PREMISES MUST KEEP THE PLACE CLEAN AND UNDAMAGED, USE ONLY AUTHORIZED TAPE, USE OF NAILS, SCREWS TACKS, STAPLES, ETC IT IS PROHIBITED. IT IS ALSO PROHIBITED TO DESTROY THE ORGANIZATIONS PROPERTY.
- 8. RENTAL GROUPS ARE RESPONSIBLE FOR THEIR OWN LIABILITY INSURANCE. THE SOCIETY IS NOT LIABLE FOR ANY CLAIMS FOR INJURY, INCLUDING DEATH, ANY DAMAGES, OR LOSSES RELATING TO USE OR OCCUPANCY.
- 9. IF THE RENTER DOES NOT HAVE A LIQUOR PERMIT, NO LIQUOR WILL BE ALLOWED TO SERVE.
- 10.THE SOCIETY IS NOT LIABLE FOR ANY PERSONAL BELONGINGS, EQUIPMENT, ETC OF RENTAL GROUP WHICH IS LOST OR DAMAGED.
- 11.PARENT OR PERSON(S) AUTHORIZED BY A PARENT IS RESPONSIBLE FOR MINORS USING OR OCCUPYING THE CENTER.
- 12.ALL TECHNICAL PROBLEMS MUST BE REPORTED TO THE BUILDING MANAGER IMMEDIATELY.
- 13.THE BUILDING MANAGER IS RESPONSIBLE FOR CALLING THE EMERGENCY SERVICES; AND IS THE PERSON IN CHARGE IN ANY EMERGENCY SITUATION. THE SECONDARY, THE PRESIDENT OF THE POLISH FRIENDSHIP "ZGODA" SOCIETY, MUST BE IMMEDIATELY INFORMED BY THE BUILDING MANAGER ABOUT THESE SITUATIONS.
